## **Preface**

This manual contains information you need in order to safely install and operate your Excelsior-488 laser. An Excelsior-488 system consists of a laser head that produces blue light (488nm) and a controller, connected by an umbilical cable.

Excelsior is designed to be an OEM product, and all power and command signals are intended to be provided by a master system to the laser through the controller.

A brief description of the contents of each of the chapters is provided below.

Chapter 1, "Introduction", contains a brief description of this laser system and its components.

Chapter 2, "Laser Safety," is required reading before the system is installed and operated. The Excelsior lasers are Class IIIb devices and, as such, emit laser radiation that can cause permanent eye damage.

Chapter 3, "System Description," contains a short section on the operating principles of the laser, followed by a more detailed description of the Excelsior laser's specifications.

Chapter 4, "Installation and Operation," describes the procedures and requirements for first installing and then operating the laser.

Chapter 5, "Troubleshooting and Service," will help guide you to the source of any problems with the laser. Do not attempt repairs yourself while the unit is still under warranty; instead, report all problems to Spectra-Physics for warranty repair. "Customer Service" in this chapter gives information on service calls and warranty issues.

Chapter 6, "Warranty and Compliance", summarizes the warranty and associated conditions and provides information regarding the procedures for laser return. This chapter also summarizes the standards to which the lasers comply.

Every effort has been made to ensure that the information in this manual is accurate. All information in this document is subject to change without notice. Spectra-Physics makes no representation or warranty, either expressed or implied, with respect to this document. In no event will Spectra-Physics be liable for any direct, indirect, special, incidental or consequential damages resulting from any defects in this documentation.

# **Unpacking and Inspection**

## **Unpacking Your Laser**

Your Excelsior laser was packed with great care, and its container was inspected prior to shipment—it left Spectra-Physics in good condition. Upon receiving your system, immediately inspect the outside of the shipping container. If there is any major damage (holes in the container, crushing, etc.), insist that a representative of the carrier be present when you unpack the contents.

Carefully inspect your laser system as you unpack it. If any damage is evident, such as dents or scratches on the covers, etc., immediately notify the carrier and your Spectra-Physics sales representative.

Keep the shipping container. If you file a damage claim, you may need it to demonstrate that the damage occurred as a result of shipping. If you need to return the system for service at a later date, the specially designed container assures adequate protection.

## **System Components**

Two main components comprise an OEM Excelsior laser system:

- Excelsior laser head
- Excelsior controller

#### Accessories

Included with the laser is a Certificate of Compliance and an accessory kit. The following accessories are shipped standard with the system:

- •1 laser umbilical cable (1.8m)
- •1 interlock jumper plug





# **Chapter 1: Introduction**

The Spectra-Physics Excelsior-488 laser produces a blue (488 nm) continuous wave laser beam from a very compact package. These small, rugged solid-state lasers are especially well suited for applications requiring a low-noise, high-quality, CW visible beam. Excelsior lasers are intended for OEM integration into master systems.

The Excelsior laser family consists of a number of different lasing wavelengths and optical powers. All Excelsior lasers deliver efficient, stable light with excellent spatial mode that is critical for a wide variety of applications. Please refer to the Newport / Spectra-Physics website for the latest product information.

Excelsior-488 lasers produce single longitudinal mode continuous wave beams of exceptional wavelength stability and narrow line width, with fixed optical output power, depending on the model, from 10mW to 100mW. The same controller operates all Excelsior-488 laser heads. However, Excelsior-488 laser heads and controllers are not interchangeable with components of Excelsior lasers of other wavelengths.

The laser heads are designed for precision mounting and alignment of the beam, which, together with the specified bore sighting of the output, simplifies the task of designing the master optical train, or replacing a laser head in the master system. All of the optical components are contained within the laser head itself.

The lasers are controlled by the master system by means of analog signals provided through a connector on the controller and/or via the 5V power supplied to the controller.





# **Chapter 2: Laser Safety**

Follow the instructions contained in this manual to ensure proper installation and safe operation of your laser.



**CAUTION:** The Spectra-Physics Excelsior-488 lasers are Class IIIb lasers as defined by the Federal Register 21 CFR 1040.10 Laser Safety Standard. The standard requires that certain performance features and laser safety labels be provided on the product. Images of the warning labels in place on the laser are shown later in this section.



**WARNING:** This product produces laser light at 488nm. Diffuse as well as specular beam reflections can cause severe eye or skin damage. Residual invisible light at 976nm wavelength might also be present.

The American National Standards Institute publishes a laser safety standard for users entitled American National Standard for the Safe Use of Lasers (ANSI Z136.1). Spectra-Physics strongly recommends that laser users obtain and follow the procedures described in this ANSI standard. Copies may be obtained from:

**Precautions for the Safe Operation of Class IIIb**Lasers

- Wear protective eyewear at all times; selection depends on the wavelength and intensity of the radiation, the conditions of use, and the visual function required. Protective eyewear is available from suppliers listed in the Laser Focus World, Lasers and Optronics, and Photonics Spectra buyer's guides. Consult the ANSI and ACGIH standards listed at the end of this section for guidance.
- Maintain a high ambient light level in the laser operation area so the eye's pupil remains constricted, reducing the possibility of damage.
- Avoid looking at the output beam; diffuse reflections are hazardous.
- Establish a controlled access area for laser operation. Limit access to those trained in the principles of laser safety. Enclose beam paths wherever possible.
- Post prominent warning signs near the laser operating area.
- Install the laser so that the beam is either above or below eye level.
- Set up shields to prevent any unnecessary specular reflections or beams from escaping the laser operation area.
- Set up a beam dump to capture the laser beam and prevent accidental exposure

# **Safety Devices**

#### **Emission Indicator**




Figure 1 – Showing the position of the laser head LED emission indicator

There is an emission indicator on the laser head, as shown in Figure 1.

The emission indicator is a bi-color LED. It glows AMBER (YELLOW) when electrical power is present in the laser head, and GREEN when laser current is present. A GREEN indicator means that the laser can emit 488nm light (this includes the warm-up period of the laser). During the warm-up period, output power fluctuates as the laser self-calibrates. During this time, the output power of the laser may briefly exceed the nominal power of the laser. Maximum emission levels are given later in this section.




Figure 2: Illustration of features on the Excelsior controller.

The presence of the laser head cable and connector can obscure visibility of the laser head emission indicator. For this reason it is recommended that the system integrator set up an additional emission indicator. This can be done using Pin 14 of the Control Interface. The location of the Control Interface connector is shown in Figure 2. A description of the function of Pin 14 is given in Chapter 4.

#### Remote Interlocks

There are two ways to implement a remote interlock.

 The 5V DC power supply to the laser may be interlocked. When the power is removed the laser will turn off. When the power is re-applied, the laser will restart, beginning with its warm-up sequence. The disadvantage of this method is that the interlock switch must be rated for the full supply current of the laser.





2. Pin 2 of the Control Interface is a LASER ON/OFF input. It is internally pulled high, in which state the laser is prevented from operating. Connecting Pin 2 to GND (Pin 11 and/or Pin 12 of the Control Interface connector) will cause the laser to turn on. An interlock loop from Pin 2 to the selected ground pin(s) (Pin 11 and/or Pin 12) when interrupted, will cause an immediate shut down of the laser current. An interlock jumper plug is provided with the system to allow operation without an external control cable. The location of the Control Interface connector is shown in Figure 2. The function of the Control Interface is described in Chapter 4.

### Safety Interlock

The Excelsior-488 laser has no covers or panels which are intended to be removed. The laser head has a protective cover which prevents access to laser radiation except via the laser aperture. There are no user serviceable parts inside either the laser head or controller. The covers are not intended to be removed and cannot be removed without tools. Therefore, the laser by itself has no safety interlocks.

#### **Shutter**

The Excelsior-488 laser has no shutter or beam stop on the laser aperture. This must be taken into consideration by the system integrator.





**Key Control** 

A key control is not provided as part of this OEM laser system. Key control required by safety standards such as IEC60825-1 can be implemented using the LASER ON/OFF function of the Control Interface or by interruption of the 5V power supplied to the controller, as described under "Remote Interlocks" above. In this case the key switch is implemented as one switch in the remote interlock loop.

## **Maximum Emission Levels**

The following are the maximum emission levels possible for the Excelsior-488 laser. Use this information for selecting appropriate laser safety eyewear and implementing appropriate safety procedures. These values do not imply actual system power or specifications. Laser light at 976nm is generated in the production of the 488nm emission. This infra-red wavelength is substantially confined to the inside of the laser head.




Figure 3 – Controller main label




Figure 6 - Label locations on controller




Figure 12 - Locations of labels on the laser head

# Requirements for Safely Operating the Excelsior Laser System with a User-provided Control Device

When the Excelsior laser system is controlled by a device provided by the user or software written by the user, the following must be provided:

- A key switch that limits access to the laser and prevents it from being turned
  on. It can be a real key lock, a removable computer disk, a password that
  limits access to computer control software, or a similar "key" implementation.
  The laser must only operate when the "key" is present and in the "on" position.
- An emission indicator that indicates laser energy is present or can be
  accessed. It can be a "power-on" lamp, a computer display that flashes a
  statement to this effect, or an indicator on the control equipment for this
  purpose. It need not be marked as an emission indicator so long as its function
  is obvious. Its presence is required on any control panel that affects laser
  output.





Schedule of Maintenance in Accordance with Center for Devices and Radiological Health (CDRH) Regulations



**NOTE:** This laser product is intended for OEM use. Therefore, an application has not been submitted with the Center for Devices and Radiological Health (CDRH) for compliance review. However it is recommended that the same schedule of maintenance be followed as that for systems that comply with these regulations. Once a year, or whenever the product has been subjected to adverse environmental conditions (e.g., fire, flood, mechanical shock, spilled solvent, etc.), check to see that all features of the product identified function properly. Also, make sure that all warning labels remain firmly attached.

- 1. Verify that opening any safety interlock switch used with the system prevents laser operation.
- 2. Verify the laser can only be turned on when the master system key-switch is in the on position, and that the key can only be removed when the switch is in the off position.
- 3. Verify the user-supplied emission indicator provides a visible signal when the laser emits accessible laser radiation that exceeds the accessible master system emission limits for Class I<sup>1</sup>.
- 4. Verify the time delay between turn-on of the user-supplied emission indicator and the start of laser emission; it must give enough warning to allow action to avoid exposure to laser radiation.
- 5. Verify that when the interlock loop is opened the master system shutter closes and actually blocks laser radiation emission. If any of the above items fail to operate as noted and you cannot correct the error, please call your Spectra-Physics service representative for assistance.

# **Chapter 3: System Description**

## **Excelsior Laser Head**

The Excelsior-488 laser head consists of two key functional sections. The first section is responsible for generation of the high power 976nm light and the second section is where the 976nm photons are converted into the visible, 488nm output. More details of each of these sections are provided below.

#### 976 nm External Cavity

The 976nm output is produced by a high power telecommunications grade 976nm semiconductor laser. In order to produce the required wavelength stability and selectivity, the semiconductor chip (to be referred to as the gain chip) is placed inside an external cavity. Within the external cavity, there is an optical element that is highly wavelength selective. This wavelength selectivity forces the laser to operate on a single longitudinal (cavity) mode. As a result of this external cavity configuration and the laser control scheme, the laser also operates mode-hop free. The stable, narrow line-width output of the external cavity is used to generate the visible light via second harmonic generation, as described below.

#### **Frequency Doubling**

In the Excelsior-488 laser, the infrared output from the high power 976nm external cavity laser is converted to visible light through frequency doubling (also called "second harmonic generation") in a nonlinear crystal. Frequency doubling occurs when an intense laser beam enters a nonlinear crystal and generates a second beam at half the incident wavelength.

Phase matching is a requirement of nonlinear optics to achieve an efficient conversion of the fundamental incident light to a new wavelength. To produce any significant output at the new wavelength, the fundamental light wave and the converted light wave must stay in phase over a sufficient length in the nonlinear material to allow the conversion to take place. In most nonlinear materials, however, the indices of refraction at the two wavelengths will be significantly different, causing the two waves to become rapidly out of phase unless special techniques are employed. To address this issue, the Excelsior-488nm laser uses a periodically poled crystal. The periodic poling allows efficient second harmonic generation over the entire length of the crystal.

#### Mechanical and Thermal Design

The mechanical design of the miniature laser heads allows for mounting the laser using precision alignment pins. Together with the excellent stability and bore sighting specifications of the Excelsior, this facilitates both the design of the master optical train as well as the replacement of the laser head.





The Excelsior Controller

Power for the laser, as well as monitoring and control, are provided to the laser head through the small, separate controller unit. An interlock jumper plug is provided with the system to allow operation without an external control cable during test and installation.

# **Power Supply Requirements**

The Excelsior requires up to 10 Amps of regulated +5 VDC power to drive the laser head. This power consumption refers to the absolute worst case ambient conditions (40C) during laser startup.




Figure 13: Ambient Temperature and Relative Humidity **Operating Range**

# **Chapter 4: Installation and Operation**



Read this chapter in its entirety before attempting to install and operate the laser.

#### Installation

Excelsior lasers are OEM devices designed to be integrated into a master system that provides all of the necessary electrical power, control signals and regulatory safety features. System connections are described below in "Controls and Connections."

An Excelsior laser head is connected to the controller by an umbilical cable that provides on/off control of the laser, as well as diagnostic information. The cable connects to the 26Pin MDR connector on the controller.

Electrical power for the laser is provided to the controller through the 9-pin POWER connector. To provide a margin of safety, select a cable capable of carrying at least a 10 Amp current to connect to the controller. Because of the high initial current draw, make sure that the load is shared between the pins on this connector. Refer to "Controls and Connections" below.

Thermal management of the heat load produced by the laser is important to maintaining its specified output characteristics. Refer to "Thermal Management" below for details.

#### **Power Supply Requirements**

The laser is to be powered by a low-noise (150 mV ripple peak-to-peak), 5 VDC power source connected to the controller. The source must be capable of providing 50 Watts (10A maximum current).

## **Thermal Management**

#### Laser Head

The laser head must be mounted on a heatsink capable of maintaining its base plate temperature below 55% and greater than 4%. It is recommended that a heat-sink with a thermal impedance of less than 0.5 C/W be used with the Excelsior-488 laser head, to ensure proper operation in a 40% ambient environment.

#### Controller

The Excelsior controller transfers a significant current load in a relatively small package to the laser head in order to power the laser head. Consequently, a reliable means must be provided to remove waste heat from the controller in addition to the laser head. Follow standard practices to mount the controller on a heatsink with a thermal impedance of no greater than 2°C/W.





## **Installing the Hardware**

## **Mounting the Laser Head**

Follow standard practices to mount the laser head on a suitable heatsink as described in the preceding section. Mechanical dimensions of the laser head are provided in the figure below.




Figure 14: Mechanical Dimensions of the Excelsior-488 Laser Head

#### **Mounting the Controller**




Figure 15: Mechanical Dimensions of the Excelsior Controller

Follow standard practice to mount the controller on a suitable heat sink as described in the preceding section. Mechanical dimensions of the controller are provided in Figure 15.

## **Controls and Connections**




Figure 16: Excelsior Controls and Connections

The only control for the Excelsior-488 laser is the LASER ON/OFF control pin on the Control Interface connector, shown in Figure 16 as the "External Control Cable Connector".

When the laser is turned on, it will execute a self-calibration sequence which typically takes less than five minutes, but may take up to seven minutes. When this sequence is completed, the laser maintains a fixed output power according to its factory set point.

There is an INTERNAL/EXTERNAL control switch on the side of the controller, as shown in Figure 16. This switch is for future functionality and has no function at present.

#### Follow the instructions below to operate the Excelsior-488 laser.

- 1. Connect the umbilical cable to the laser head and the controller.
- Connect the cable carrying the +5 VDC power to the 9-pin POWER SUPPLY D-sub connector on the controller. This is a MALE connector on the controller. Verify the cable is securely fastened to the controller. NOTE: +5 VDC in Pins 1, 2, 6, and 7, Ground (return) Pins 4, 5, 8, and 9.
- Install either the supplied Interlock Jumper Plug or an appropriate cable with a 15-pin D-sub connector to the EXTERNAL CONTROL connector on the controller

The 15-pin D-sub connector on the controller is FEMALE. The function of each of the laser control pins is listed below.

- 1. **Output Laser OK:** This pin is internally shorted to ground when the laser is in stable operation, i.e., laser output power is at the specified level and the laser head temperature is within the proper operating range.
- 2. **Input Laser ON/OFF:** When this pin is shorted to ground, the laser will turn on (if +5 VDC power is available to the laser head through the controller).
- 3. N/A Reserved: Must be open
- 4. **N/A Reserved:** Must be open
- Output Laser Power Monitor: Pin 5 provides an output signal that is approximately proportional to the optical power output of the laser. At full output power, the signal is 95–100 mV.
- 6. Ground
- 7. Ground
- 8. **N/A Reserved:** Must be open
- 9. **N/A Reserved:** Must be open
- 10. **Output Diode Laser Alarm:** Indicates that the gain chip current is nearing its end of life value.
- 11. Ground
- 12. Ground
- 13. **N/A Reserved:** Must be open

**Chapter 5: Troubleshooting and Service** 

## **Maintenance**

The Excelsior laser head and controller require no routine maintenance. Do not remove the outer covers; there are no user-serviceable parts inside either the laser head or the controller. Service is generally limited to replacement.

## **Troubleshooting**

This troubleshooting guide is intended to assist you in isolating some of the problems that might arise while using the system. For information concerning the repair of this unit, please call your Spectra-Physics representative.

Symptom: No Laser Beam

Possible Causes	Corrective Action
No ON signal applied to the controller	Pin 2 of the EXTERNAL CONTROLLER must be pulled to ground to turn the laser on
Improper power supply voltage	Verify the DC power supply voltage is between 4.5 and 5.5V and that the power supply is capable of supplying at least 50W of power.
Loose cable connector	Check that all cables are securely connected.
Improper settings for the INTERNAL/EXTERNAL switch	Ensure that the INTERNAL/EXTERNAL switch is set to the INT position.

Symptom: Low Power

Possible Causes	Corrective Action
Improper power supply voltage	Verify the DC power supply voltage is between 4.5 and 5.5V and that the power supply is capable of supplying at least 50W of power.
Loose cable connector	Check that all cables are securely connected.
Improper settings for the INTERNAL/EXTERNAL switch	Ensure that the INTERNAL/EXTERNAL switch is set to the INT position.
Incorrect power measurement	Ensure that the output power is measure where it leaves the laser head (before any external system optics.) Ensure that the power meter is calibrated and set for the appropriate laser wavelength
Laser is not warmed-up	Wait for the laser to reach its operating state
Reflected light is impacting the internal power control loop	Block all potential forms of back-reflection and retest the laser





**Symptom: Unstable Laser Operation** 

Possible Causes	Corrective Action
Improper power supply voltage	Verify the DC power supply voltage is between 4.5 and 5.5V and that the power supply is capable of supplying at least 50W of power.
Loose cable connector	Check that all cables are securely connected.
Improper settings for the INTERNAL/EXTERNAL switch	Ensure that the INTERNAL/EXTERNAL switch is set to the INT position.
Laser is not warmed-up	Wait for the laser to reach its operating state
Reflected light is impacting the internal power control loop	Block all potential forms of back-reflection and retest the laser
Power supply ripple	Ensure that the power supply meets the ripple specification
External noise source	Check that there are no strong electromagnetic noise sources near the system.

## Warranty

All parts and assemblies manufactured by Spectra-Physics are unconditionally warranted to be free of defects in workmanship and materials for the period of time listed in the sales contract following delivery of the equipment to the F.O.B. point.

Liability under this warranty is limited to repairing, replacing, or giving credit for the purchase price of any equipment that proves defective during the warranty period, provided prior authorization for such return has been given by an authorized representative of Spectra-Physics. Spectra-Physics will provide at its expense all parts and labor and one-way return shipping of the defective part or instrument (if required). In-warranty repaired or replaced equipment is warranted only for the remaining portion of the original warranty period applicable to the repaired or replaced equipment.

This warranty also does not apply to equipment or components that, upon inspection by Spectra-Physics, is found to be defective or unworkable due to abuse, mishandling, misuse, alteration, negligence, improper installation, unauthorized modification, damage in transit, or other causes beyond the control of Spectra-Physics. In addition, the warranty will be void if the laser head cover is removed.

This warranty is in lieu of all other warranties, expressed or implied, and does not cover incidental or consequential loss.

#### Returning the Instrument for Repair

Contact your nearest Spectra-Physics field sales office, service center, or local distributor for shipping instructions. You are responsible for one-way shipment of the defective part to Spectra-Physics. Instruments can be returned only in Spectra-Physics containers. We encourage you to use the original packing boxes to secure instruments during shipment. If shipping boxes have been lost or destroyed, we recommend ordering new ones.
